

Last year I worked as an Environmental Technician and it taught me a lot about Provincial and Federal Ministries, The Regulatory Processes', and introduced me to the various indigenous movements that are meant to protect the environment. My lateral transition to Mineral Development Advisor has allowed me the opportunity to focus on Mining within our traditional territory, and although I have a lot to learn, I believe that I am serving the community to the best of my ability. The Lands and Resources Department has provided on -going training opportunities that are helping to fine tune my skills and knowledge and I am very appreciative. For example, I have recently participated in a weeklong training for "Environmental Monitoring", provided

through Blue Heron Environmental. This training was so transformative to my understanding of Mining on Indigenous Lands, that I am setting up a community outreach virtual meeting to share with all those that are interested. ### **ELDER'S CARE FUNDING**

### Purpose:

Missanabie Cree First Nation's Family Services Team has set out the following guidelines based on funding available from the Ministry of Health and Long Term Care. Requests that fall outside of this scope of funding are to be submitted as a RAMA request which is subject to Chief and Council approval.

Due to the amount of funding provided, Missanabie Cree has set limits on amounts that can be applied to this funding specifically to ensure we are able to make services available for all elders.

Elders of Missanabie Cree First Nation are able to apply for services and reimbursements of eligible costs by completing the Family Services Intake form.

If the request does not meet the funding criteria, or are over and above the limits set below, the remainder of the request is then submitted to Chief and Council to be considered under the RAMA Health category.

The Ministry of Long Term Care (MOHLTC) provides funding to First Nation communities to cover expenses in the following categories (A, B, and C). Under these categories we are providing the services listed below by way of direct pay to providers or reimbursement to the individual making the request:

- A) Community Support Services
  - a. Meal Services
  - b. Transportation
  - c. Caregiver Support Services
  - d. Adult Day Programs (1-2 days per week)
  - e. Home maintenance and repair
    - i. Maintenance includes: snow removal, mowing
    - Repairs include: leaking roof/water damage, and any damage or repair required that significantly affects the state of being able to remain living in the home safely
    - iii. Accessibility modifications (renting vs home ownership may have different eligibility)
  - f. Emergency Response Services
  - g. Foot Care
- B) Homemaking/Personal Support Services (4 hours per week)
  - a. Housecleaning
  - b. Laundry
  - c. Shopping
  - d. Preparing Meals
  - e. Assisting a person with personal hygiene or routine activities of living

### **ELDER'S CARE FUNDING**

- C) Professional Services (Must provide receipts for reimbursement)
  - a. Occupational therapy and assistive devices
  - b. Physiotherapy
  - c. Speech-language pathology Services
  - d. Dietetic services
  - e. Diagnostic and laboratory services
  - f. Medical Supplies and treatment equipment
  - g. Pharmacy Services
  - h. Respiratory Therapy Services

Missanabie Cree First Nation under the funder's requirements are expected to:

- · Assess the person's requirement for community services
- Determine the eligibility for community services
- Develop a plan of service for each eligible person
- Set out the amount of each service provided to the person
- Review the person's requirement regularly and revise plan of services as necessary when changes are required

Additional Emergency Services provided not under MOHLTC related:

- 1. Rental Assistance for arrears (1 month paid, once per elder)
- 2. Last month's Rental assistance (Once per elder)
- 3. Dental care and denture (costs over and above NIHB coverage/other insurances may be eligible)
- 4. Prescription glasses (costs over and above NIHB coverage/other insurances may be eligible)
- 5. Diabetic needs (special circumstance) (costs over and above NIHB coverage/other insurances may be eligible)

### **ELDER'S CARE FUNDING**

### Steps for processing and approval

### Step 1 - application

Contact the Family Well-Being Worker via phone 705-254-2702 ext. 206 or email at jharris@missanabiecree.com.

Request to complete the Family Services Intake form. You will be asked to provide information and documentation for back up.

Information needed to complete the form:

- Personal Information (Contact, mailing address, status number, date of birth)
- Details for the request (situational details)
- Quotes/Service Fees/detailed bill
- Doctors note (nature of the need, duration, frequency)
- Letter of support from organizations (if applicable)
- Letter of denial (if applicable from NIHB, insurance, other entities)

All applicants must sign the release of Information section which enables staff from Missanabie Cree First Nation o contact medical professionals (i.e. Doctor's, PSW's, Organizations involved in the request) when it pertains to health.

Collection of this information allows staff to ensure information is available if needed to confirm the request. All information collected remains confidential.

### Step 2 - Review

The Family Well-Being worker may ask that any missing information is obtained by the individual prior to file review and approval process.

Once documentation is received by the Family Well Being Worker, the file will be reviewed and possibly reviewed by other Family Services Staff, if required to access all available resources.

### STEP 3 – Approval Process

The Family Well-Being Worker will within 7 days inform the applicant that the information has been reviewed and will be able to identify if it has been approved under MOHLTC funding or if the file required Council review under the RAMA process.

If the file requires Council review, the Family Well-Being Worker will advise the applicant of the next Chief and Council meeting date.

Within 3 days of the next Council meeting an update will be provided to the applicant on the status or review/approval.

They are all my reason for living a good life and travelling the sweetgrass path. It is part of my vision to share and honor the good life in all the good ways I have been taught and shown by my family and Elders. This is part of my vision, to lead my community while sharing my knowledge and history of my connection to community and community building.

I am excited to offer my name for Chief in this 2022 election. My platform is quite simple but not necessarily easy. When you have a vision, passion and the love of hard work with 7 generations ahead to always think about, it gives me energy and strength to pursue this. My background and accomplishments are extensive and well suits me for the position of Chief of Missanabie Cree (MCFN). Five (5) Chiefs have paved the way forward and built us up over the years and my vision is to continue the movement and progression, along with a council that shares my passion and love of hard work. I take off my "cat in the hat" and put on my "serious hat" and set aside the fun and games to do the leadership that is required of Chief.

I give recognition and praise to the late Honorary Chief John Fletcher, our first Chief for his courage and wisdom to sign those documents and begin the journey of Missanabie Cree First Nation.

it is important that I recognize the work done by Chief Jason Gauthier. He has made gains in the business world and has been recognized for his work in economic development along with the staff of Missanbie Cree Business Corporation and I honor that. Jason and I go back a long way and he has supported me in many of my fun and entertaining projects over the years and our friendship continues. I wish him the best in all his future endeavours.

The start of my vision is: A CHANGE IS NEEDED.

Joint Ventures and Partnerships review and reporting system that inform Chief and Council who in turn pass on the information to membership in tangible and concrete reporting. This will include a complete review of who they all are, what they do, where they are, how they benefit our community and anything else that is identified that can be shared.

I have 9 years' experience of being a member of MCFN Chief and Council, (1991 to 1999) the first 3 years as Deputy Chief and the other 6 years as Councilor. Under the leadership of Chief Nolan and Chief Rainville, the building of Keekinaw, the multi-purpose facility was both a labor of love and conflict, but it is what is today, a beautiful building with cooking and meeting space plus a safe room for children that live with autism to seek that quietness and solace they require for personal comfort. I lobbied for that space and with funds granted from Chief Gauthier's Council, I furnished it. Keekinaw is our home and gathering space at Island View. Little did former Chief Shirley Horn know that the purchase of Island View and creation of annual summer gatherings would grow to what it is today.

I would aim to work with the Elder Committee and help to move it to a progressive and productive place of community involvement.

I would work diligently with those who have intent to settle on the land. We need to be on the same page as far as understanding our Cree values, legal and financial positions of MCFN and our capabilities and limitations. As Cree people we are meant to work together to come to like-mindedness. We can work towards a win-win accord to suit those most concerned.

<u>2. Office Overview</u> that includes program review, job descriptions, wage review, office space & equipment, benefit package, recognition of years of service, retirement packages, program department manuals that list duties and the how to accomplish them.

For 26.5 years, I managed Marjorie House a 24 hour-7day-a-week shelter for abused women and their children. I gained extensive knowledge of office administration including human resources, financial management, planning and development of programs and implementation, public relations and education, union negotiations and maintenance of union contract. My job as Executive Director was supervised by a professional Board of Directors, coming from many different professions.

I have been in 3 positions at MCFN office;

- 1. Community Development Coordinator
- 2. Cultural Facilitator
- 3. Post-Secondary Education Officer/Cultural Facilitator (on election leave).

Since 2017, I have seen some gains but have also identified where improvements and change are needed, with no threat to anyone's position.

### 3. Culture and Language

I began seeking teaching and Indigenous knowledge in the early 90's, picking up on many different cultures from British Columbia to west coast of James Bay Mushkegowuk, southern Ontario Mohawk, Plains Cree Alberta, south to Mexico, Arizona Apache, Hopi, Navajo. What I found out later is that we are all related. We all have our own creation stories, ceremonies, languages and dialects. In my walk I gained many teachings and now can focus on our natural history of Mushkegowuk Cree.

A decision I made in 2012 was to return to school and completed 4th Year program of Bachelor of Education at Brock University, specializing in Aboriginal Adult Education. This led me to work for George Brown College in Toronto for five (5) years, teaching in Liberal Arts and Sciences Womens Programs and Indigenous Studies.

I have a long-standing involvement with community development with MCFN, starting before I was elected in 1991.

- -attended first Council Fire held in winter at former Ernie's campground
- -sat on Rama committee as Chairperson when first created developing policies
- -made the Community Eagle Staff
- -brought many different forms of entertainment for community development, showcasing and promoting alcohol/drug free fun
- -chairperson for MCFN first Pow Wow
- -Co-chair of first Cultural Cree Camp which will be a launch in bringing our Cree dialect forward

### 4. Education

I was sent this information from a dear friend when i first started working in the education position:

"the battle for Indigenous children will be won in the classroom. The students of today are our warriors of tomorrow."

The world is contantly changing. one of the strengths of our people has been our adaptability. In today's world, education is what we need to survive. We need doctors, lawyers, teachers, scientists. We can become these things and still live in a cultural way. We need to live in both worlds, the educated world and the Cree cultural world. Education is what will help protect our land, our health and enhance the knowledge of our people. We must support all our students in the best way we know how while they are attending to their education, primary, secondary and college-university, and all the way to Masters and PHD's. At the same time we must teach the language, the culture, the ceremony and the traditions of our people.

My favourite saying:

#### Education is Knowledge, Knowledge is Power and Power is Choice.

A relevant factor of my decision to run for Chief is that this will be my first time in my work history that I will be focused on **ONE JOB** only. In all my other work life I have done multiple positions. I look forward to the idea of one job only and that is progressive leadership of MCFN and carry on the work created, developed and implemented by all former Chiefs. I vow to be proactive not reactive, inclusive in all my tasks, fairness and honesty while promoting positive role modeling of governance.

My name is Lois MacDonald; I am a proud member of the Missanabie Cree First Nation and a recognized Elder within the community I work and live in.

When I first thought of running for Band Council, I did a lot of soul searching asking myself why? My answer came and it was quite simple; it's time to start working for your First Nation. I believe my skills, knowledge and experience I gained from working within the community of Cambridge where I live, as well as the surrounding areas will be an asset to our Band Council.

I have previously worked in the field of employment and training as well as community development by building relationships with the non-Indigenous organizations or businesses. The intentions of building these relationships were to open doors to assist our Indigenous community members on a personal or professional basis

The past 10 years my professional journey has taken another direction. I worked 4 years within post secondary education system guiding and supporting the students personally while getting their education. Working in an educational institution taught me how to work within a system that has certain policies and procedures in place to follow as an employee. This brings me to where I am currently at today. I am self-employed as an Elder with Corrections Services Canada. I work with the Indigenous women who are incarcerated, by guiding, teaching and supporting them on their healing journey. The majority of the women did not know their culture growing up and started to learn for the first time while incarcerated.

Not only do I work in Corrections, I also sit at the table as the Regional Elder for Mushkegowuk Council holding space for the Chiefs to do their work. It is an honour, privilege and a gift to be given this opportunity to sit with the Chiefs who represent their communities with honour and dignity. I am very humbled to be given this opportunity, as I mentioned previously it is a privilege, an honour and a gift.

When I look back at my journey in life, whether it was personally or professionally; I realized I have always been working for the people in one capacity or another.

What I learned for the past 24 plus years of working for the people (personally or professional) will and can carry over to begin my work for the members of Missanabie Cree First Nation as a Band Councilor. Wachiye! I'm Bobbi Fletcher, youngest child of our First Chief John Fletcher Sr. and Hazel Fletcher. I'm mom to Conner and Jackson, and I also have a bonus son named Dakota. I'm a Social Worker who had worked in Child Welfare for over 20 years. Currently, I am a Community Wellness Worker at Ontario Native Women's Association (ONWA).

I'm a current Councilor, who has served on the Missanabie Cree Council for 3 terms, one as Deputy Chief.

Within this past term, we all experienced the difficulties that arose with the Covid pandemic. Chief and Council had been meeting weekly, then we met bi-weekly (the same schedule it is on now) as we went further into the pandemic.

One of the points throughout this term that I stressed, was the inclusion of all members from BC to the Maritimes. In addition, I advocated for equality across the board for this. For instance, many members did not know that we could request assistance for a variety of reasons (i.e. support for members children who are not status); and I ensured that this was shared on all forums including the Bear Fax.

Further, sponsorship for recreational activities had been supported by our Chief and Council. However, there needs to be a policy in place whereby it is fair and equitable for all who are seeking it. I believe that this is being worked on.

My current platform is to continue to ensure that Chief and Council represent <u>all</u> of Missanabie Cree First Nation. Throughout conversations with members, I understand that there needs to be increased transparency. I would ask for quarterly reviews of our financial statements, with increased open band meetings. These would be scheduled well in advance, to ensure that everyone is aware of them, and can actively participate in them. Within the open band meetings, Council would be expected to present on their portfolios.

The Governance Committee needs to be supported to meet more often, so that policies and codes could be completed in a timely manner. This also includes the Housing Policy, which the governance committee is currently working on. When these policies and codes are completed and forward to Chief and Council, Chief and Council need to commit to review and pass them in an equally timely manner.

Further, there needs to be open communication between Chief and Council, and the members of our First Nation who currently reside in Missanabie, and those who want to move to Missanabie. We need to meet often (monthly) to ensure that the voices and experiences of our members have an open and safe place to discuss their questions and concerns.

I believe that our current Chief and Council did the best we could do considering the pandemic. I do think there is room for improvement with regards to open communication and transparency, and with your support in this upcoming election, I will continue to represent <u>all</u> members of our First Nation.

#### WACHAY MCFN FAMILY AND FRIENDS

My name is Jutta Horn and I am the daughter of Shirley Horn, Grand-daughter to Gilbert and Mary Fletcher and Great-grand daughter of James Fletcher. I am a second generation survivor of the residential school system and I am thankful to be able to stand here today not only as a candidate for political office but as a strong, proud Cree woman of the Missanabie Cree First Nation.

### A LITTLE ABOUT MYSELF:

I have always been inspired by the words and actions of my mother and former Chief, and her unending commitment and dedication to our nation and to make the move back to the land, which she did in 2007. Her passion became my passion and for the past 25 years I have been invested and committed to advancement of our First Nation and our Vision with the desire to do the same.

I graduated with a Diploma in First Nations Business and Administration (1995) and a University Degree in Community, Economic and Social Development, which I completed in 2007. In 1998, I moved my family from the West Coast to Sault Ste. Marie, Ontario. Although I knew very little about our people, I was confident that this move would bring me closer to my nation and to the opportunities where I could become a greater participant in our nations' rebuilding process.

Since 1998, I have worked for our First Nation in various capacities (Economic Development Officer; TLE Land Transfer Advisory Committee Coordinator; Tripartite Forestry Agreement Coordinator; Comprehensive Community Development Coordinator) and served as an elected Band Council member from 2007-2013.

#### WHAT I STAND FOR:

As part of a group of members who are dedicated to return to the land, I am deeply concerned with the manner in which the current leadership has chosen to dismiss the concerns of this group and how they have presented the situation to the rest of our membership.

As a member who was encouraged by previous leadership to make our way to the land, some of us took the initiative to do this and we have been situated on our traditional lands for almost 20 years now. We are harvesters, hunters and gatherers and we have been the eyes and ears of our traditional homeland in the absence of having a reserve to call home.
