about the per capita distribution which Council had discussed at our last Chief and Council meeting. With the stock market plummeting and inflation rates increasing by the day, our investments have seen significant declines in the interest earned on our Trust investments to date. Unfortunately, our returns were very minimal this year leaving no extra room for membership distributions in the budget although we, were still able to identify some additional dollars from other funding pots that could be gifted to members to help during the holiday season. These gifts will be express posted to members in the coming week so please ensure that the Band office has your correct address.

As Deputy Chief, I have been very busy the past couple of months. I have attended many meetings and functions representing our community and advocating for the very important issues and challenges we face as a First Nation community.

We have met with our Financial Advisors in reviewing our Trust investments and making the necessary changes to ensure our Trust investments are protected and secured moving ahead into the future. We understand the expectations of our members but we are also cognizant of the current financial situation and obligations we have in paying down remaining debt and in managing the funds for the future generations. We have been advised that the markets are going to get worse before they get better and we are preparing for those impacts.

MCBC RUSH EVENT – MCFN recently hosted the MCBC Rush Event. This was an event that brought together industry and business partners in Sault Ste. Marie for a two-day conference to network and explore potential

business ventures and opportunities that MCFN and others could collaborate on. I enjoyed this event as it gave me an opportunity to get to know our business partners on a deeper level and to understand the working relationships we have forged with these individuals and companies in our business development activities. We have some really great partners working alongside MCFN and incredible opportunities to grow our nation in partnership with these companies.

I also attended the Mushkegowuk Health Summit recently to advocate and lobby the Ministries of Health and ISC to bring greater awareness and greater financial supports to the ongoing health struggles we are all facing in our communities. Our community representatives did a fantastic job and worked hard over three days to identify our community health needs and to deliver those messages to the

agencies, representatives and those in assembly. In our efforts, we were successful in garnering the attention of the Ministry of Health to work with us over the coming weeks to develop the plans and priorities that will help us strengthen and expand the services, programs, and supports for our people.

I have also been working with the Mattawa Chiefs and Mushkegowuk Chiefs in building a relationship agreement to collaborate on developing a consultation framework that addresses resource development activities occurring on our Traditional Lands. Each community has different needs and circumstances and in developing these agreements it is imperative that every community has the opportunity to incorporate a process that is community led and community driven. This is a fundamental component of building a system that serves to meet the needs of every community in this process. Although there has not been an agreement signed yet, this is something that we are striving to complete as soon as possible.

We have much work to do and I

am hopeful that the new year brings greater opportunity and relief to those who are currently struggling. We are a strong nation and we have managed to get through the worst of times and we will get through this.


interest in wanting to become involved with MCBC. For this event I was asked to do the opening and closing.

Happy holidays everyone,

I hope that this holiday season is a wonderful one for you and your families.

Governance has been quite busy. We are in the midst of finishing a draft of our land code. We have one more meeting with the Governance Committee and a few of our staff before bringing it to our Land Code Sub-committee. After we meet with the Land Code Subcommittee, we will be bringing the Land Code to Council for review. Next the land Code goes to the Community. This process will consist of myself, a Governance Committee Member, visiting the hubs along with the Hub Coordinator of each community where we will be presenting the draft that has been created. We will be looking for your feed back and presenting thecurrent draft of the Land Code. We will also be making available every hub, this presentation an an online event

as well. This is how we intend to inform our membership of the work we have done with our Land Code.

With regards to the

Administration Code, this is to be ratified in the near future. I will getting this document ready to be sent out in a similar way that our last version of our Election was so keep an eye out for this and make sure your addresses are up-to-date with June.

As some of you know, I have taken on the health lead within our community with regards to Covid. As I write, I am just finishing up attending the Moving Forward Health Summit 2022 with Mushkegowuk Council. There have been many topics with regards to the Opioid Crisis, First Nation and Inuit Health Benefits. (NIHB) and how we can better service our community Members.

Our Chief's have declared a state of emergency with the lack of health care our communities have been receiving. It's time we move forward. During this summit we have identified the need to develop strong health systems within our communities. Our current health system is hostile toward our people and we all need better support all around.



With concern to the Opioid Crisis, it effects us all, we all have someone in our family who is battling this disease. It touches us all. There are so many overdoses in every one of our communities and identifying our next steps was something our group has examined as well. Mushkegowuk assured us that they are here to help. During our breakout sessions we covered many areas and brain stormed with the questions that were given to us. Together, myself, Deputy Chief Jutta Horn, our Program Developer Lesley Gagnon, our Youth Rep Alethea Pezzo, our Elder Liaison Lori Rainville, and Kim Rainville, one of our former Chiefs, all came together and discussed the needs of our community with regards to services that our members can benefit from.

There were many discussions and solutions that came from with this meeting. This included cultural, traditional health, and infrastructure. There were many questions asked and many great ideas that were brought to our (Continued on page 10) Festival Season Moon

table. We asked, how can Mushkegowuk be present without a financial strain to Missanabie? How do you balance Missanabie with services with Mushkegowuk? We would like services available to Missanabie at no cost to our First Nation. We would like OMA to be more present in our community. We would like an overview of services that OMA provides. We determined that there is a need to establish a health department in the near future and at this moment we need to incorporate OMA's services. We discussed the need to recruit and retain staff in our community. We also need to advocate and lobby for Missanabie to obtain more funding to expand to our new/ joined department. We want at least a 5-year contribution agreement from Indigenous Services Canada to secure services for health for our member's. We need to establish local agreements with Health services in the area to service our

members as well. We should have Mushkegowuk provide the health services that they provide in Timmins here for our member's. We talked about the possible restructuring of our Family Services by either amalgamating Family Services with Health or creating a new Health Department all together. We identified that health services should include wholistic care, traditional care, land-based care, western medicine, all integrated all into Health. This should include food security/ sovereignty that includes community engagement. We discussed the need for more visits from Mushkegowuk Council to be more informed. From this, we identified that we need funding geared towards needs rather than population and put more immediate pressure on the government. Easier access is also needed to create easier access to NiHB covered services and to have a better understanding of what is covered and available through our pharmacies for member's. We asked the question, why can't the government partner

with service Canada and have access to the secure status cards through those venues. This would in turn give better access for those who may have lost their status cards and cannot access services. We determined that we need to go to FNIHB to get finding a based on needs rather than population. With NIHB, the website is not user friendly, and people find it difficult to find the information they need for reimbursement. It's determined that we are in need of a better self serve system like the CRA website. We found that pharmacies are not wanting to process through NIHB when it comes to over the counter medications and supplies because the system has a lengthy process in place and the reimbursement from NIHB takes months.

It was also discussed that the process to appeal denials is also difficult to navigate leaving members unable to obtain the medications of medical devices needed for their health.

We also determined that there (Continued on page 11)

needs to be a more user-friendly list of what's available to the members so we can stop paying for things that are covered. We also discovered that there are services that Mushkegowuk provides help our members navigate through NIHB and it's called Patient Navigation Services.

With addictions and the opioid crisis, we determined that our children need more education. Even our adults need more education on the effects of drugs and why one would use. We also agreed that our community is in need of a Healing Lodge and a treatment center on our land. Somewhere where our member's can go and be the lead on bringing healing to our sister First Nations. This place can bring land-based programs for addictions and education. This will bring a connection to our land, Mother Earth. One thing that this pandemic has taught us is that virtual is something that we can embrace to bring these services to our land and our community. We identified that this is only the beginning, that we need aftercare and have our families involved, judgements put aside. We need those family support systems. We need to remember we are all family and support one another rather than judge.

So this Health Summit was informative and we had our voices heard. Next steps are creating more health resources within Missanabie Cree First Nation both in Sault Ste. Marie, in Missanabie, and have some services available for those who are not in those areas. Outreach is a big part of how our First Nation operates.



Wachiaye MCFN Members,

The Lands and Resources Department would like to bring to your attention that an area of forest along Highway 651 near the Dalton turnoff, is scheduled for harvest in Missinaibi Forest Management Inc.'s Annual Work Plan for 2022. Please refer to the figure below for greater clarity of where this block is located.

The block totals 229 Hectares and is comprised of mature Jack Pine. Due to its age and that it is a relatively pure stand of Jackpine, it poses a significant fire hazard. Harvest of this block would help reduce the risk of fire in this area and therefore also to neighboring communities of Missanabie and the Missanabie Cree First Nation reserve lands.

The silvicultural treatment that is common for pure stand conifers, is a Clear Cut harvest system. 25 trees per hectare are to be left for wildlife habitat and patches of stands are also to be left to



Several members have indicated on a previous traditional ecological knowledge study that they have harvested blueberries and medicines in this forested area. With careful harvest of the trees, blueberries will become more plentiful in this area as they will get greater sun exposure.

The Lands Department for Missanabie Cree has reached out to the members who have identified values in this area hoping to discuss their concerns and how the lands department can support them. We invited the group to a face to face meeting and field tour at the Annual Gathering. Invited values holders (Continued on page 16)






Figure 1 Harvest Block 599

to a virtual meeting on October 25th at 6:30 p.m. and offered

a raffle prize for their attendance. One member attended and we discussed their concerns and the various conditions that we could impose on the forest company in order to get the blessing of Missanabie Cree values holders for harvest of the trees in this area.

Therefore, on behalf of the values holders, Missanabie Cree First Nation Lands Department will be stipulating to the forest company that harvest of this area should only occur in Winter, using high flotation tires, and that subsequent regeneration of this area should exclude the use of mechanical site preparation (scarification of the soil) and under no circumstances should there be chemical tending (herbicide spraying). Hopefully this work to provide oversight of the activities of the forest companies is recognized as being beneficial to the membership. In the coming weeks we will be posting several expressions of interest for the opportunity for further member participation. Specifically there will be a call out to fill 3 positions on the Resettlement Subcommittee. to gain interest in forming a Forestry Committee, and finally to find a suitable candidate to champion into a training program for the position of Housing Manager.

I wish all of you a good Freeze up and Light Scattering moon, and a happy holiday with your loved ones. We look forward to working with you, and for you, in 2023!

ELDER'S CARE FUNDING

Purpose:

Missanabie Cree First Nation's Family Services Team has set out the following guidelines based on funding available from the Ministry of Health and Long Term Care. Requests that fall outside of this scope of funding are to be submitted as a RAMA request which is subject to Chief and Council approval.

Due to the amount of funding provided, Missanabie Cree has set limits on amounts that can be applied to this funding specifically to ensure we are able to make services available for all elders.

Elders of Missanabie Cree First Nation are able to apply for services and reimbursements of eligible costs by completing the Family Services Intake form.

If the request does not meet the funding criteria, or are over and above the limits set below, the remainder of the request is then submitted to Chief and Council to be considered under the RAMA Health category.

The Ministry of Long Term Care (MOHLTC) provides funding to First Nation communities to cover expenses in the following categories (A, B, and C). Under these categories we are providing the services listed below by way of direct pay to providers or reimbursement to the individual making the request:

- A) Community Support Services
 - a. Meal Services
 - b. Transportation
 - c. Caregiver Support Services
 - d. Adult Day Programs (1-2 days per week)
 - e. Home maintenance and repair
 - i. Maintenance includes: snow removal, mowing
 - ii. Repairs include: leaking roof/water damage, and any damage or repair required that significantly affects the state of being able to remain living in the home safely
 - iii. Accessibility modifications (renting vs home ownership may have different eligibility)
 - f. Emergency Response Services
 - g. Foot Care
- B) Homemaking/Personal Support Services (4 hours per week)
 - a. Housecleaning
 - b. Laundry
 - c. Shopping
 - d. Preparing Meals
 - e. Assisting a person with personal hygiene or routine activities of living

C) Professional Services (Must provide receipts for reimbursement)

- a. Occupational therapy and assistive devices
- b. Physiotherapy
- c. Speech-language pathology Services
- d. Dietetic services
- e. Diagnostic and laboratory services
- f. Medical Supplies and treatment equipment
- g. Pharmacy Services
- h. Respiratory Therapy Services

Missanabie Cree First Nation under the funder's requirements are expected to:

- Assess the person's requirement for community services
- Determine the eligibility for community services
- Develop a plan of service for each eligible person
- Set out the amount of each service provided to the person
- Review the person's requirement regularly and revise plan of services as necessary when changes are required

Additional Emergency Services provided not under MOHLTC related:

- 1. Rental Assistance for arrears (1 month paid, once per elder)
- 2. Last month's Rental assistance (Once per elder)
- 3. Dental care and denture (costs over and above NIHB coverage/other insurances may be eligible)
- 4. Prescription glasses (costs over and above NIHB coverage/other insurances may be eligible)
- 5. Diabetic needs (special circumstance) (costs over and above NIHB coverage/other insurances may be eligible)

ELDER'S CARE FUNDING

Steps for processing and approval

Step 1 - application

Contact the Family Well-Being Worker via phone 705-254-2702 ext. 206 or email at jharris@missanabiecree.com.

Request to complete the Family Services Intake form. You will be asked to provide information and documentation for back up.

Information needed to complete the form:

- Personal Information (Contact, mailing address, status number, date of birth)
- Details for the request (situational details)
- Quotes/Service Fees/detailed bill
- Doctors note (nature of the need, duration, frequency)
- Letter of support from organizations (if applicable)
- Letter of denial (if applicable from NIHB, insurance, other entities)

All applicants must sign the release of Information section which enables staff from Missanabie Cree First Nation o contact medical professionals (i.e. Doctor's, PSW's, Organizations involved in the request) when it pertains to health.

Collection of this information allows staff to ensure information is available if needed to confirm the request. All information collected remains confidential.

Step 2 - Review

The Family Well-Being worker may ask that any missing information is obtained by the individual prior to file review and approval process.

Once documentation is received by the Family Well Being Worker, the file will be reviewed and possibly reviewed by other Family Services Staff, if required to access all available resources.

STEP 3 – Approval Process

The Family Well-Being Worker will within 7 days inform the applicant that the information has been reviewed and will be able to identify if it has been approved under MOHLTC funding or if the file required Council review under the RAMA process.

If the file requires Council review, the Family Well-Being Worker will advise the applicant of the next Chief and Council meeting date.

Within 3 days of the next Council meeting an update will be provided to the applicant on the status or review/approval.





We have a vision of our community re-established on the traditional lands that were once the homeland of our ancestors

where institutions of our government, economy and education can once again thrive.

We have a vision of a people where individuals and families can stand strong and find healing through tradition and spirituality; individuals and families who are loving and compassionate.

We have a vision of a people who are bi-cultural and bi-lingual; a people who can walk in both worlds contributing to our well-being, the well-being of other Indigenous Peoples; contributing and competing globally.

We have a vision of a Nation of people who respect the dignity of all; a people who find balance through equality.

We have a vision of people who respect the environment, harvesting and reaping the resources of the land in a sustainable manner as responsible stewards for the use of future generations.

We are the Omushkego of the Missanabie Cree Ililiwak; whose vision it is to regain and restore our rightful place and through the strength of our people, never again be denied our place in society.
