### UN Declaration on the Rights of Indigenous People was

finally and officially endorsed by Canada on November 12, 2010. Canada, along with three other nation states, US, Australia, and New Zealand were the only countries who voted against the adoption of the Declaration at the 61st General Assembly of the United Nations in September 2007.

Although Canada has officially endorsed the Declaration, there remain many outstanding issues involving our people and the federal government. Among them are unfulfilled treaty obligations, land claims, failure to fully fund our communities in the areas of child welfare and education.

As part of his mandate from the United Nations to report on the overall human rights situations of indigenous peoples in selected countries, the UN Special Rapporteur, James Anaya recently completed a 9-day visit to Canada in October. Anaya met with many indigenous communities and organizations during his visit.

At the conclusion of his visit, Anaya commented "Canada faces a crisis when it comes to the situation of indigenous peoples of the country," The economic gap between aboriginals and nonaboriginals hasn't narrowed, treaty and land claims remain unresolved and "there appear to be high levels of distrust among aboriginal peoples towards government at both the federal and provincial levels."

Following the visit, the Special Rapporteur will prepare and make public a report on the visit's findings, which will be presented to the UN Human Rights Council in September 2014.

Missanabie Cree First Nation had a visit from the People's Inquiry on the Suicide Pandemic Commissioners here in Sault Ste. Marie. It was held at the Indian Friendship Centre on East Street on Oct. 29-30. It was posted on short notice and that was a

serious oversight on my part for not posting it in the time it was required to be posted.

The People's Inquiry is a process that was designed by the Mushkegowuk Council to encourage the community to present their views and recommendations about mental wellness and to work towards the development of a regional plan that will assist in reducing or eliminating the suicide pandemic in our region.

We had a small number of people share their stories,

experiences on suicide. They were everyday people, professionals in the field, public servants. The Commissioners listened and recorded their presentations so they can be put together in a report to the Chiefs and be handed to them for their use.

### MCFN Governance Project

[An MCFN community member posed a question regarding the Governance Coordinating Committee. The following is the response.]

The Governance Coordinating Committee has been in existence since 2011. The Governance Strategic Plan outlined a process and work plan whereby this committee would undertake the development of good governance tools. The Governance Strategic Plan was developed during a series of community meetings that were facilitated by the Mushkegowuk Governance Project in early 2011.

The Governance Coordinating Committee (GCC) has worked with the Project Coordinator in the reviewing, updating and development of our governance codes. The first year we worked on the election and citizenship codes. The next year we continued work on the election and citizenship codes and began the development of an administration code. These particular codes are expected to form the foundation of good governance practices in MCFN. The election code and the citizenship code were reviewed by legal counsel, who made many excellent recommendations. Chief and Council are currently in the process of reviewing the election and citizenship codes. Once the approval process is finished, the final drafts will go to the membership for ratification. The draft administration code will be finalized at the next meeting of the GCC. Then it, too, will be sent to Chief and Council for their review and approval.

The members of Governance Coordinating Committee have volunteered many hours of their time on this project. The process of developing and refining these codes through successive drafts has taken longer than was planned, but it is worth the time and mental effort taken to participate in these discussions which are facilitated by teleconference as well as face-to-face meetings here in the Sault. The time and expense required to do the work well benefits the community in the long run.

The Governance Coordinating Committee is appointed by the MCFN Chief and Council who base their decisions on responses to call-outs for participation, generally posted in the Bear Fax newsletter. Because of the nature of this project, Chief and Council look for specific skills in the volunteers that will ensure the process moves along because there are many issues that arise out of discussion on these important governance codes. This is why a letter of application and a resume are part of the recruiting process for volunteer participation in this project.

For this year, the GCC will oversee the development of specific policies that fall under the administration code. These are Chief and Council policy, conflict of interest policy, and redress (grievance) mechanisms.

The GCC continues to endeavour to raise awareness in the MCFN community about good governance practices. At the last Gathering in August, there was a Governance Room where information was made available to people who wished to learn more about governance, and the MCFN Governance Project. Updates have been and will continue to be regularly posted to the newsletter. Drafts of codes requesting feedback are periodically mailed to membership. Invitations to contact the Governance Coordinator for more information are included in both the newsletter updates and the mail-outs.

The Project itself is partially funded by Aboriginal Affairs through their Governance Development Initiative with additional funding through MCFN's Rama Fund.



#### ELSIPOGTOG FIRST NATION'S ANIT-FRACKING PROTESTS AGAINST SHALE GAS EXPLORATION IN NEW BRUNSWICK.

CTV News, October 23, 2013, FREDERICTON – New Brunswick Premier David Alward is brushing aside criticism that there hasn't been enough consultation with First Nations about shale gas, saying his government has had more discussions with them than any past government in the province.

He said his government remains committed to developing natural resources, including shale gas. But he added that shale gas development is only at the exploration stage and further discussions will be held before the province proceeds.

"There would have to be very significant consultations and environmental impact assessments before anything else would be able to move forward," Alward said.

Critics including the New Brunswick Anti-Shale Gas Alliance have said last week's violent clash in Rexton, N.B., between shale gas protesters, including members of the Elsipogtog First Nation, and police could have been avoided had the provincial government done a better job of consulting with them.

To further its case, the government released a chronology of meetings it held over the past year with energy company SWN Resources and First Nations.

"Not only has the Crown met its consultation requirements for the current seismic program, but has gone above and beyond to ensure that First Nations have full details about the current program," Energy Minister Craig Leonard said in a statement Tuesday.

"As we have said all along, if oil and gas reserves are found through the exploration process, the government and proponents would have to enter into further consultations with First Nations to ensure that the environment was protected and that Aboriginal peoples benefited from oil and gas development."

Forty people were arrested and weapons including guns and improvised explosive devices were seized last Thursday when the Mounties enforced a court-ordered injunction to end the blockade of a SWN Resources storage compound for exploration equipment and vehicles. Six police vehicles including an unmarked van were burned. The RCMP said they had Molotov cocktails tossed at them, and in response they fired non-lethal beanbag-type bullets and used pepper spray to defuse the situation.

The RCMP blocked Route 134 at the end of September after protesters began spilling onto the road. The Mounties said traffic is now able to pass, but protesters, including members of Elsipogtog, remain at the site.

Alward has met Elsipogtog Chief Aaron Sock in an effort to resolve the situation and he said Wednesday his officials are trying to set up another meeting with the leader.

#### CHIEF OF ELSIPOGTOG CONSIDERS LEGAL ACTION

The chief of the First Nation at the centre of an ongoing dispute over shale gas development says his community will go to court to try to take control of Crown lands in New Brunswick. Elsipogtog First Nation Chief Aaron Sock made the announcement Thursday after meeting with the Assembly of First Nations National Chief Shawn Atleo.

"It's gone past the SWN stuff," Sock said, referring to the dispute between protesters and SWN Resources Canada. "It's gone past the fracking. Right now, we're at a point, we're staking claim to the lands. We're reclaiming the ownership and that's where it's at. Let's settle it once and for all. Let's go to court."

Sock said he and his community members came to the decision after prayer and discussion. They say legal action is the only way to resolve the impasse with the prov-

ince. Sock said the concern shouldn't be with blocking roads or fighting with companies.

"Because at the end of the day, the real question is the title of the land," he said. "Once we can distinguish who actually is the rightful owner, then we can start talking about extracting natural resources." CBC's Jennifer Choi reported that if legal action is taken, all shale gas development in New Brunswick could be put on hold.

Atleo said Thursday the federal government must work with all bands to ensure treaties are implemented in the aftermath of violent clashes last week between the RCMP and members of the Elsipogtog First Nation near Rexton.

He told CBC News from Elsipogtog that the dispute is about "a long-standing non-recognition of treaties that were forged before Canada was even formed, that the United Nations Declaration of Rights of Indigenous Peoples reflects back to Canada are still in full force and effect. And that the people of Elsipogtog, like indigenous nations across Canada, have the right to free, prior and informed consent over all aspects of their lives, including on issues of resource development."

Some members of Elsipogtog were arrested a week ago when the RCMP enforced a court-ordered injunction at

the site of a protest outside a compound where SWN Resources stored exploration equipment and vehicles.

Atleo said the situation in New Brunswick provides an opportunity to spark discussion and action. First Nations have won over 150 court cases across the country, he said. "This is why we're pressing all levels of government, particularly the federal and provincial governments, to sit down meaningfully with First Nations on a nation-to-nation, treaty-by-treaty basis, to work together to see the implementation of those treaty nights, which belong to First Nations and in fact they belong to all Canadians as well."

Meanwhile, six men arrested during the Rexton clash remain in jail as bail hearings proceed at a snail's pace. The six men face 37 charges, including uttering threats, forcible confinement, and obstructing a police officer.

The slow pace of the bail hearings had supporters crying foul. About 40 people, many from Elsipogtog First Nation, have been in court to show support for the accused. Peter Dauphinee believes the police wanted to send a message with their intervention in the protest on Route 134 on Oct. 17. "I think the whole thing was to scare the protesters," said Dauphinee

### AFN CHIEF RESPONDS TO THE RELEASE OF "A PROPOSAL FOR A BILL ON FIRST NATION EDUCATION"

October 23, 2013

(Ottawa, ON) - Today, Assembly of First Nations (AFN) National Chief Shawn A-in-chut Atleo responded to the release of the federal government document "A Proposal for a Bill on First Nation Education". The federal government says it will receive feedback on this proposal up to early January 2014 and this will precede any tabling in Parliament of legislation on a First Nation Education Act.

"First Nations have been clear about serious concerns with both the federal process to date as well as what is

required to support First Nation student success," said National Chief Atleo. "We have been very vocal in what we are seeking: an approach that respects our rights and enables First Nations control of First Nations education. Our children and students deserve safe and good schools and supporting their success with fair and stable funding that will address the gaps while supported by strong First Nations systems and delivering a curriculum that respects our rights and our languages. This work is tremendously important to First Nations and is a top priority. The federal government must meaningfully and immediately engage with First Nations. We must get this right, right now."

AFN Nova Scotia-Newfoundland Regional Chief Morley Googoo, who holds the Education portfolio for the AFN, said: "Aboriginal Affairs Minister Valcourt met with the Chiefs Committee on Education on Monday October 21st and they delivered a direct message that First Nations must be fully and meaningfully engaged in the design, development, and implementation of First Nation education. We absolutely need an ongoing engagement to get to a positive outcome that will support the success of First Nations students."

The AFN and the Chiefs Committee on Education will be providing a detailed analysis of the proposal and other information to assist First Nations in their review of the federal document.
