It's been a year since I started working for Missanabie Cree First Nation. The time has sure gone by soooo quickly.

After two weeks of Christmas vacation, we were slated to return to work on January 5th; however that did not happen due to a toilet tank leak on the second floor that created considerable damage to sections of the second and ground floor. Luckily Louise dropped by the office on Sunday, January 4th to discover the water leak. After she called the insurance company, Service Master arrived on the scene to start the clean-up and a plumber removed the leaking toilet. The clean-up took longer than anticipated because the water-logged rugs and sub-floor had to be removed and the plywood flooring dried. We are starting our new year off in the right direction by acquiring the consulting firm of MacLeod Farley and Associates to determine the viability of transforming Island View Camp into an all-season tourism facility. He brings a wealth of experience to MCFN to complete the task of evaluating this venture to generate economic growth and prosperity. His past projects include the Cree Village Eco Lodge for MoCreebec, Tom Thomson Art Gallery – Owen Sound, and the Hope Island Lighthouse - Beausoleil First Nation.

Following the selection and the conclusion of the RFP (Request For Proposal) process, we were delighted to meet and greet Member of Parliament, Brian Hayes and Tracy Forsyth of FEDNOR in our office on December 18, 2014. They were here to record the "live" Funding Announcement with Chief. Jason Gauthier, of their investment into Island View Camp, totalling \$90,00 of government approved financial support. FEDNOR is committed to allotting additional funds should our team arrive at a dynam-

ic business case, comprehensive feasibility study

The project scope includes the following:

- Review of the current and past operations from top to bottom including financial performance, business operations and condition of the site, facilities and systems
- Identify new target markets based on current and potentially improved assets
- Develop an improvement plan (including cost and funding) for needed upgrades to the facilities and, if viable, new four season accommodations
- Develop an overall Business Plan to reflect upgraded and expanded facilities, financing sources, improved management and marketing and year round operations.

POST-SECONDARY EDUCATION OFFICER

Happy New Year!

In this article I will give an update on the Post-Secondary Education Funding we receive and the application process for funding.

If you are planning to attend an accredited postsecondary institution for the upcoming fall 2015, you should be applying to the school of your choice now. For this reason, you will have all documentation needed for your application for funding with Missanabie Cree by the deadline date of June 15, 2015. This includes secondary students, too, as your acceptance into a college or university will be conditional upon graduating from grade 12.

So the first step is to apply to the colleges or universities that offer programs of interest. There will be an applica-

tion fee and this will vary from province to province.

Once you receive an offer of admission and you accept one, then you will receive an acceptance letter.

The acceptance letter is what is needed for the application for funding with Missanabie Cree.

Call me, Lori Rainville, and ask for an application for funding. The following is needed:

A letter from you stating your education plan and goals. Tell me why you selected this program. Tell me what your plans will be once you complete your program. Do you require a degree or diploma to obtain employment?

- A copy of your acceptance letter from college or university.
- Official transcript may be needed if you did not sub-

mit a final one previously.

- Completed application form funding, this requires information as to whether you are married, have dependents etc. You will have to provide verification if you are claiming your spouse as a dependent and this will also verify any children as well.
- All the above documentation is to be received by our office no later than <u>June 15, 2015</u>.
- If your application is late it will not be reviewed until all documentation is received and it will be subject to availability of funds.

All applications received by June 15 are reviewed and prioritized by categories. The costs of tuition, allowance & books for both new and continuing students are calculated to reach a balanced budget. Sometimes we don't have enough funds to cover all requests so these people will be placed on a wait list in the event that there are funds recovered.

The post-secondary budget for the 2014/2015 fiscal year is \$340,760.00.

Typically this budget will allow us to fund approximately 20 to 24 students depending on the type of program and institution. Tuition can vary from province to province, Ontario has the highest rates to date. This fiscal year we were able to fund 23 students, 9 new students. This year we are estimating 8 graduates.

The post-secondary funding received annually covers tuition, books & living allowance. Living allowance is for full time students only. For example to fund a full time student to attend a university can range from 13,000 to 20,000 a year. So as you can see funds are limited.

If you have any questions regarding post-secondary education and our application process please contact me by phone or email.

On January 14, 2015 the Band Manager, Victoria Pezzo and myself were able to meet regarding recommendations that came from the past gatherings. We have to follow up with some research before we meet again. Three items we discussed were an Education Conference, bursaries and increasing allowances. These are all very important items and we will do the best we can to make these happen. When you ask? Well, all of these three items require funding, so we will keep you up to date on our progress via the Bear Fax.

What happens if a vacancy occurs on Council, including the Chief's position?

Process of Determining a Vacancy

If any position on council becomes vacant for any reason under the provisions of sub-section 13.1.1, then the following process shall be followed, as outlined under Section 13 of the Election Code: Vacancies of the MCFN Custom Election Code

1 - Notice Notice with valid evidence to be presented at regular Council meeting, calling for position to become vacant.

> In order for the position to be declared vacant, a quorum of council must pass a resolution.


2 - Interim Appointee

If a vacancy is created in the Office of Chief, the Deputy Chief shall assume the office of Chief until the next election.

If a vacancy created in the office of councilor, the position shall remain vacant, if 6 months or less remain until the next election, unless it is necessary to maintain a quorum of council.

If there are more than 6 months remaining in the office of councillor, the candidate who ran for election, and received the most votes next to the last councillor shall be designated as councillor.

LAWRENCE MARTIN ELECTED MUSHKEGOUWK GRAND CHIEF



On November 14, Lawrence Martin was elected Grand Chief of the Mush-kegowuk Council.

A Swearing in Ceremony took place on November 26, 2014 at 9 am at the Delta Waterfront Hotel in Sault Ste. Marie prior to the Mushkegowuk Chiefs Meeting.

Archie Nolan, MCFN Elder, conducted the ceremony which was attended by the Mushkegowuk Chiefs as well as MCFN staff and members.

Grand Chief Martin will serve the remainder of the term for the position of Grand Chief which was left vacant by the death of Dr. Stanley Louttit.

Lawrence Martin, who is a member of the Moose Cree First Nation, beat out six other candidates in a by-election. He has also served as Mushkegowuk Grand Chief before, from 1998 to 2001.

The grand chief position has been open since the death of long-time leader Stan Louttit, who lost a battle with cancer in June.

"We have a lot of the housing issues, we have a lot of the water and sewage problems," Martin said of the challenges he will face as Grand Chief.

The Mushkegowuk Council represents eight Cree communities in northeastern Ontario: Attawapiskat First Nation, Chapleau Cree, Fort Albany First Nation, Kasheche

"But there's all kinds of money out there. Minister Rickford just announced the Canada Build program that has millions and millions of dollars and now we can actually start applying for those funds for the infrastructure in the communities."

After Martin served a term with Mushkegowuk Council, he was active in off-reserve politics. He served as mayor of the towns of Cochrane and Sioux Lookout.

Martin is also an accomplished musician. He won a Juno music award for Best Music of Aboriginal Canada Recording in 1994, and was co-nominated for the Juno for Aboriginal Recording of the Year in 2003.

COMMON EXPERIENCE PAYMENT RECIPIENTS NOW HAVE MORE TIME TO APPLY FOR, REDEEM, AND USE PERSONAL CREDITS

December 17, 2014 - Ottawa, ON - AANDC
Bernard Valcourt, Minister of Aboriginal Affairs and
Northern Development, today welcomed the decision of
the Supreme Court of British Columbia to grant Canada's
request for an extension to the deadlines to apply for,
redeem, and use Personal Credits. Parties to the Indian
Residential Schools Settlement Agreement requested
the deadline extension in order to give Common Experience Payment recipients and their family members the
best opportunity to access Personal Credits to support
education opportunities.

The Indian Residential Schools Settlement Agreement provides that Common Experience Payment (CEP) recipients may apply for Personal Credits. Personal Credits have no cash value and can be shared with up to two family members. They are redeemable for either person-

al or group educational services provided by approved educational entities and groups. Personal Credits have a maximum individual redemption value of \$3,000.

New deadline dates will be determined once the court order is signed by all parties, but today's court decision allows for a two month extension from the date of the court order to submit an application for Personal Credits. It will also allow for a five month extension from the date of the court order for Education Entities and Groups to submit redemption forms for payment. August 31, 2015, is the new deadline for CEP recipients, or their family members, to complete courses or programs for which Personal Credits are used.
