



## CULTURAL FACILITATOR

Aanii to all:

I am now settled in my new office located in Echo Bay, former Castle Building. You would be quite surprised at the renovations completed here that have accommodated more office space. There is more furnishing needed to complete this space and soon it will be a hubbub of activity, filled with workers and ongoing business promoting and expanding our First Nation.

I would love to see signage on both sides of the road entrance and on the outside of the building.

Last week I met with Danis Janvier, Surface Superintendent for Alamos Gold. We reviewed the draft of my training plan that is completed so far. This training manual will be implemented to all personnel at Alamos mine site. Target start date is June 4<sup>th</sup>. In the meantime, there will be more writing to the manual and meetings to review and refine. In the manual I can incorporate Indigenous Knowledge and Worldview and use the Medicine Wheel and Stages of Life with Culture and without Culture to demonstrate this.

Our knowledge is grounded in language, led by spirit and translated through culture. Our land is fundamental for cultural identity. Our worldview is defined by the land and nationhood of people where we talk about spirit, the circle, all living beings and stages of life. It is my intent to use this in the first chapter as a pathway to creating awareness on the sacredness of our land, air, and water.

Councillor L. Nolan and I attended Alamos Gold mine site on Monday, April 16 for the Environmental Committee meeting. It was quite the education in geology and science. Max Morin, Environmental Superintendent, provided an excellent overview and details of the Q1 Highlights and Annual Environmental Report. We had a ground tour, mind you it was in 4-wheel drive due to the amount of snow that fell and was still falling! From all reports reviewed Alamos is following no effluent released in Q1 and annual reports submitted to MOECC. The compliance and diligence are evident, and it was explained that the Ministry does not schedule site visits, they just show up and do their samplings. If the mine was not in compli-

ance, they would face very large fines and be published.

I attended an Elder Meeting with a few others and in attendance was former Chief, Glenn Nolan, now Elder Representative to Land Claim negotiations. There will be a report coming from this meeting, just not sure who is the author. Stay tuned as it is all good news.

Other areas I am working on or a part of is the start of planning for a Pow Wow at the Gathering in 2019. Discussion on location is a big part of the process and assistance and guidance will be needed from Chief and Council. I am also working on Accessibility for children who live with Autism, to make a sensory space and other inclusive accommodations at the upcoming Gathering.

## POST-SECONDARY EDUCATION OFFICER

Dear Members,

**Congratulations to all upcoming graduates!** Have you applied for graduation yet? Have you informed your education officer? Are you excited?

**Post-secondary applications for 2018 – 2019 academic year are available.** Hard copies are available as are electronic versions. Deadline is coming up quickly. Applications for the upcoming **academic year of 2018 – 2019 are on the website.** Print off a copy, complete it and send it in to the attention of Education Officer. You may send it by direct email, fax or via postal service.

**Deadline for a September start for academic year 2018 – 2019 applications is May 15<sup>th</sup>, 2018 – to be received in the office by that date.**

If you do not have all the required documents with your application, call me directly as to when to expect them. If you have any questions, even the ones you are just vaguely wondering .... Please call to chat. There is no such thing as too many questions.

### ONGOING Post-secondary STUDENTS

Please remember to be getting summer jobs. An academic year is generally eight months. Also, you need to apply each academic year: this is also true for part-time students. If you do not apply by the deadline, the monies may not be available.

### All Students and potential students

Funding is not guaranteed. Transcripts/official academic summaries are required at the end of each semester. Reimbursements for transcripts are available. Monies for extra books is dependent upon funds being available: please plan your budgets according to the information on the Appendix. Students are responsible to know the terms of their agreements and the policies that are used. Having questions is a good thing.

Missanabie Cree First Nation education policy is on the website: look for the members tab, then in the education sub-tab. The National Guidelines for Indigenous Services Canada post-secondary program for 2018-2019 are available: you may search for “psssp 20182019” on the Government of Canada website.

All continuing and new students are requested to apply for alternate sources of income such as student loans, grants, bursaries, awards and scholarships. Each post-secondary institution has financial supports available for indigenous students. It is the student’s responsibility to apply for these extra supports. The financial support provided through our post-secondary student support program funded by the federal government is not guaranteed to cover all your costs.


### Graduates and Students from 2012 to Current Year

## CBA IMPLEMENTATION COORDINATOR



Whatchay,

Firstly, I would like to thank to family, friends, MCFN staff, and colleagues at Alamos for their well wishes and the lovely flowers and the decorative bird! . The surgery went well, and the tumor is no more. Cancer, as many will agree, can pose a

difficult time for everyone affected. In my case, I can report my recovery is progressing well, and I am optimistic I can resume work in early May.

This is good timing as we have an important marketing opportunity at the Canadian Mining Expo in Timmins, June 6th and 7th. We have acquired a booth there that will enable us to display posters and banners promoting Missanabie Cree's Business Corporation as a services source for the mining industry via both the partnership with Alamos Gold, and the joint venture agreements we have with many service/supplier companies. For example, the contract secured by MCBC for tree clearance at Island Gold and sub-contracted out to our partner Kabi Lake Forest Products can be used as an indicator of one of the services MCBC provides. This is being extended to other mine projects such as construction requirements through existing partnerships as MCBC continues

to grow and expand Missanabie Cree's portfolio for contract procurement, training and employment.

Although I conferenced into the CBA Environmental Committee meeting at Island Gold on April 16th, I must thank my colleague, the Cultural Facilitator, Gloria Harris, and Councilor Les Nolan for attending in my absence. The review included updates on permitting for the Dam Raising project and construction of dikes, a contingency pump for pumping effluent water from secondary to primary ponds, bunkhouse expansion, and related tree clearance of perimeter areas. The field component of the meeting included an inspection of the Water Management process and progress on the tree clearance at the mine. When agreed upon, it is proposed to hold a water blessing ceremony.

## PUBLIC SERVICE ANNOUNCEMENT

**CARFENTANIL IS 100 TIMES MORE POTENT THAN FENTANYL AND IS VERY DANGEROUS.****April 27, 2018**

In November 2017, illegal drugs that contained Carfentanil were seized in one of the coastal Mushkegowuk communities. The seized drugs had the appearance of Percosets and were sent to a lab for analysis. The lab tests found and confirmed that the seized drugs contained Carfentanil. The actual content was caffeine and Carfentanil. It is very common for drug dealers to "lace" other drugs and pills with this drug and in this case, they were disguised as "percs".

**Carfentanil is 100 times more potent than Fentanyl and is very dangerous.**

Carfentanil is a synthetic opioid drug approximately 10,000 times more potent than Morphine and 100 times more potent than Fentanyl. The presence of Carfentanil in illicit drug markets is cause for concern, as the relative strength of this drug could lead to an increase in overdoses and overdose-related deaths, even among opioid-tolerant users. The presence of Carfentanil poses a significant threat to first responders and law enforcement personnel who may come in contact with this substance.



## **Ontario Partners with First Nations to Share Forestry and Mining Revenues**

*Province Signs Historic Resource Revenue Sharing Agreements*  
May 3, 2018 9:00 A.M.

Ontario and First Nations partners have signed historic resource revenue sharing agreements in mining and forestry - the first of their kind in the province.

These agreements with First Nations, represented by Grand Council Treaty #3, Wabun Tribal Council and Mushkegowuk Council, commit Ontario to sharing 45 per cent of government revenues from forestry stumpage, 40 per cent of the annual mining tax and royalties from active mines at the time the agreements were signed, and 45 per cent from future mines in the areas covered by the agreements.

Resource revenue sharing will enable First Nations to share in the economic benefits of forestry and mining operations near their communities. The First Nations will have full control of the allocation of these funds into key initiatives that support economic development, education, health, community and cultural priorities.

Resource revenue sharing is one of many steps on Ontario's journey of healing and reconciliation with Indigenous peoples. It reflects the government's commitment to work with Indigenous partners, creating a better future for everyone in the province.

We have a vision of our community re-established on the traditional lands that were once the homeland of our ancestors where institutions of our government, economy and education can once again thrive.

We have a vision of a people where individuals and families can stand strong and find healing through tradition and spirituality; individuals and families who are loving and compassionate.

We have a vision of a people who are bi-cultural and bi-lingual; a people who can walk in both worlds contributing to our well-being, the well-being of our brother and sister First Nations; contributing and competing globally.

We have a vision of a Nation of people who respect the dignity of all; a people who find balance through equality of all ages, male and female alike.

We have a vision of people who respect the environment, harvesting and reaping the resources of the land in a sustainable manner as responsible stewards for the use of future generations.

We are the Anishnabe of the Missanabie Cree First Nation whose vision it is to regain and restore our rightful place and through the strength of our people, never again be denied our place in society.
