Wahchay!

Happy holidays to everyone, I hope you all enjoy your time together! As you may know, we have some exciting news for a new communication tool, an MCFN information app! This is what I have been waiting for. This app will be run through a company called Avia and is a great way to communicate in 2023! One of the biggest attractions to this Indigenous operated company was that they assured they are Elder friendly and would provide support for our community to ensure everyone is able to use this app. I am not sure when the app will be up and running but hopefully soon. I made a promise to you all, to our

I made a promise to you all, to our community that I would, in my position on council, hold at the core of all that I do honesty, accountability, transparency and that I would protect Earth Mother



to the best of my abilities. I try to take part in things I believe that are beneficial for our community, now and for future generations. I try to continue to be honest, accountable, and transparent.

I hold the lands and resources portfolio and am second on the family portfolio. I do not want to overlap what our Lands and Resources department is reporting in their own newsletter, so I will speak to the things I believe need to be shared.

This year we welcomed a new baby into our community, Nalani (pictured). With this new addition, I have been so lucky to be able to join meetings via video (Meegs Zoom!). This November 15-17 Nalani and I traveled to Sault Ste Marie to join Wahkohtowin, MCFN, Garden River FN & Brunswick House FN on Conservation Dav. At this conference I learned that Wahkohtowin is working with Mushkegowuk and many foundations including the David Suzuki, Nature Conservancy, Ecotrust, Natural Resources Defence Council, to Conserve 30% of "public" land and water by 2030. Currently Canada is sitting at 11-12%. My initial reaction was to put a big circle across the map in our territory, but to my dismay they are looking for more specific places. While I mentioned some places that I know that are important to our community I would encourage members to attend so other areas can be identified. It seems frustrating

that we can't put a huge circle over the land, but they are willing to work with us, so let's protect what we can, for now. I am so excited to say that homes are being built on Nolan Road! We hope to have four homes built by spring 2024. That said I would like to share how this all came to be and highlight some concerns I have. The homes are modular homes (trailers). Two detached 3bedroom and one duplex (both 2 -bedroom homes and one wheelchair access). We have hired a company called Northern Shield who is set to be monitored by Tulloch.

Our standard procedure for all major agreements is to request bids from companies for the work to be done. In the case of the houses, I had three bids emailed to me, however there was no discussion that took place around the bids or the information that was included in the bids. I was then emailed a BCR for funding through CMHC to be allotted to Northern Shield, saying it was the only qualified bid. I did not sign the BCR as it is irresponsible of me to commit to such a large exchange of money to such an important project without a discussion and shared my concerns with the rest of Chief and Council. It is our job to be thorough in all that we do and to ensure that we are making decisions in the best interest of our community. While I am not aware of what due diligence the other members

of Chief and Council did, I spoke to two separate former clients of Northern Shield, and both warned me that Northern Shield has a bad reputation up here in the North of cutting corners.

I would like to highlight that one bid came from our own shared company Wahkohtowin, Tree to home (Onebowl.org). According to a response I received when I questioned why we did not consider our own company was that there were small elements missing from the quote and that they would not be able to meet the December 2023 deadline outlined in the call for the bids - but that spring of 2024 would be feasible. To date Northern Shield has pushed the completion date back to spring of 2024 - thus already not meeting their own bid objectives.

I am not proud of the way that this process has taken place, nor do I stand behind the quality of what Northern Shield provides but I am thankful homes are finally being built. With the company being monitored, I feel more at ease.

I am still hoping for Wahkohtowin's "Tree to home" program, *Onebowl.org* as it "has been formed as a not-for-profit housing supply chain solution for First Nations to bring the standing trees in their territory to standing homes in their communities". Of course, there will be more homes built in the future and I believe there will still be opportunity for us to build homes that are sustainable, environmentally friendly, and built to last for our community. I truly

hope moving forward more time and consideration will be taken throughout this process. In terms of quality for a home, I believe that once the Land Code is complete, we can start moving home. Keep an eye out for Land Code meetings! I will share one last thing with everyone, Chief and Council signed a BCR for another distribution from our Trust! They will be mailed out Nov 30. impacted communities like Kashechewan First Nation. This will include supporting them during evacuations but also training their members to prepare in advance evacuation strategies. Other First Nations and regions of Indigenous Services across the country are approaching us to explore partnerships and expansion into their provinces. Emergency App - after a bit of hiatus, we reengaged ISNM on our phone app for emergency response and held several sessions to finalize the app. We anticipate launching the initial version of the app February 2024 and refining its functions in time for the evacuation season starting April 2024.

RUSH 2023 - I want to thank the team at MCBC for all their hard work in organizing this year's event. We increased our partner participation by 15% from last year, with more corporate sponsorships and vendors at our trade fair. The Delta hotel has upped their game in food quality and service. Exciting Discoveries in Bat

Conservation



I am thrilled to share some exciting news from the Lands Department regarding our recent bat conservation efforts within and around the reserve. Our team has been hard at work and the results are amazing! Using Wildlife Acoustics technology, we successfully detected the presence of Little Brown Myotis (LBM) in the area. The Little Brown Myotis is an endangered species, and now that we know they are located within the traditional territories, we can better protect them and their habitat.

We strategically placed the acoustic recorders down Puppy Lake Road, near Eskay Lake, and at the Renabie Mine site. Although we did not detect LBM on Puppy Lake Road, we recorded several other species at all 3 sites, including 3 other endangered species Big Brown bats Silver – haired bats (endangered) Hoary bats (endangered) Eastern Red bats (endangered) The ultrasonic data (pictured here) was processed using Wildlife Acoustics automatic identification program. We got over 6000 recordings in total! Each bat has a specific call shape and features that help to identify it from the rest, but they are all very similar. The next step for this project is to create a comprehensive plan that protects large hardwoods - especially poplars as the reserve is being developed. Our goal is to to safeguard these remarkable species. This project has super fun to be a part of and I am very happy with the outcome. I want to thank the summer water guardian - Ryan Wesley for all his help with this project, couldn't have done it without him! I hope everyone enjoys the holidays with family & friends, and that the new year brings good health and happiness to all. Best regards







Spectrogram (green) and oscillogram (red) showing the bat pulses. Little Brown Myotis calls start around 100kHz and end around 40kHz. Another notable feature of LBM is the smudge at at the end of each pulse.





The Little Brown Myotis is an endangered species, and now that we know they are located within the traditional territories, we can implement a strategic plan that protects large hardwoods - especially poplars, as the reserve is developed.

Other species also identified: Big Brown Bat Silver Haired Bat (endangered) Hoary Bat (endangered) Red Bat (endangered) Using the song meter mini bat from Wildlife Acoustics, MCFNs Lands Department was able to determine the presence of the Little Brown Myotis. The sound meters were placed near Eskay Lake, down Puppy Lake Road, and at the Renabie Mine site. There was no LBM found on the recordings on Puppy Lake Road, but there were a number of other species. The ultrasonic vocalizations were analyzed using an automatic identification technology.




